
## Budget Development Considerations: Expenditures Beyond District Control

### **Expenditure Offsetting Examples:**

- Health Care Cost The State provided districts with the one time availability to raise taxes over the 2.0% without going to vote to adjust for increases in health care costs. In Line B - Audubon was permitted to increase the Tax Levy by \$144,207 – 1.07%.
- Banked CAP The District elected to use \$94,079 to offset the 2024-2025 budget. Banked CAP increases the tax levy by 0.70%.



# Stabilizing Staff: Adjustments in Line Items

#### How did we recover \$288,490?

- Securing an in-house paraprofessional
- Decreases in supplies
  - o Administrative (\$1.000)
  - o Basic Skills (\$250)
  - Health Care (\$1,400)
  - o Library Media (\$2,000)
- Collapse of Freshman sports
- Decrease in stipend positions
- Anticipated breakage from retirements
- Decrease in curriculum committee participants
- Decrease in out-of- and in-district workshops

#### What positions did we save?

- Three Teaching Positions
- AHS School Counselor
- AHS Hallway Monitor



## 2024-2025 Budget Impact on Audubon Taxpayer

Increase in Tax Levy: General Fund=	\$532,194	
Increase in Tax Levy: Debt=	\$36,358	
Total Tax Levy Increase=	\$568,552	
2023 Ratables=	\$713,845,204	

The 2024-2025proposed budget represents an increase of \$0.0778 per \$100.00 of assessed value.

For a home assessed at \$209,000, this equates to an increase of \$162.56 for the year.

(\$209,000/\$100) X \$0.0778 = \$162.56

The tax increase equates to about \$13.55 per month or \$3.13 per week.
